On June 14, 2023, Pacific Merchant Association (PMA) and International Longshore Warehouse Union (ILWU) reached tentative agreement on brokered by US Labor Secretary Julie Su. After 13 months of negotiations (when contract expired July 1, 2022 when it expired), the agreement needs to be ratified through union rank and file. In August, while the ILWU leadership have fully endorsed and sent agreement to its members, ratification, which typically takes months, is far from certain as some union locals voice some descent. On August 7, 2023, Canada's ILWU union ratified their labor contract which agreement was brokered Canada's government after union issued strike action on July 18, 2023. https://www.reuters.com/world/americas/some-dock-workersemployers-canadas-pacific-port-reach-tentative-deal-2023-07-21/

With West Coast ports recovering from some labor disruptions

in June, Panama's drought crisis caused restrictions on vessels passing through Panama Canal. Since June when the restrictions started, growing backup vessels have faced delays and container transshipping. Current backlog estimated at 200+ vessels. Accounting for 40% of global shipping routes, Panama's 10 months restrictions are impacting supply chain into 2023 holiday season.

Customs and Border Protection (CBP) announced that the next Commercial Customs Operations Advisory Committee (COAC) quarterly meeting will be held on Sept. 20 from 1-5 p.m. ET. While the meeting is open to the public, there will not be an on-site or in-person option for the public to attend this quarterly meeting, the agency said.

The meeting will be open to the public via webinar only, CBP said. The webinar link and conference number will be posted by 5 p.m. ET on Sept. 19 <u>here</u>. For information or to request special assistance for the meeting, contact Ms. Latoria Martin of CBP's Office of Trade Relations, at (202) 344-1440 as soon as possible.

CBP said there will be "multiple public comment periods" during the COAC meeting. Speakers are asked to limit their comments to two minutes or less to "facilitate greater participation."

Comments for this COAC meeting must be submitted by Sept. 15 and identified by Docket No. USCBP-2023-0021. CBP said submissions received must also include the words "Department of Homeland Security." All comments received will be posted without change <u>here</u>.

Indirect Source Rule (ISR) Poses Serious Threat to Port Operations

Southern California may create a regional port authority later this year, making the port authorities of Los Angeles and Long Beach irrelevant, if a proposed rulemaking by the South Coast Air Quality Management District (SCAQMD) is approved.

The SCAQMD, a regional air quality agency representing Los Angeles, Orange, Riverside and San Bernardino counties, hopes to enact a Port Indirect Source Rule (ISR) for the ports of Los Angeles and Long Beach by December 2023, a rule that would cap cargo volumes at the nation's busiest container gateway.

Despite the fact that all port operations-related emissions sources are currently regulated — through international treaties, federal law, state regulations, port policies, tariffs and lease agreements — the ISR attempts to create new jurisdictional power for a regional agency over mobile emissions. Ironically, the ISR does not reduce emissions, and the SCAQMD cannot directly regulate mobile sources — i.e., cars and trucks, aircraft, trains, ships and other equipment that can move from one area to another.

This power grab would extend the SCAQMD's regulatory

authority beyond state, federal and international laws and regimes, would impede interstate and international commerce and would effectively shut down investment at the largest US port complex.

The SCAQMD is not mandating specific equipment upgrades or technology enhancements, nor is it setting emission limits for individual supply chain elements, as the California Air Resources Board has done in the past. Instead, SCAQMD bureaucrats are setting hard target dates for total emission reductions on all supply chain components and making those reductions the responsibility of the ports and terminal operators, regardless of whether they have a contractual relationship with those entities.

NCBFAA Joins PMSA and 110 Organizations Warning L.A., Long Beach Against Indirect Source Rule

NCBFAA joined approximately 110 other trade organizations, led by the Pacific Merchant Shipping Association (PMSA), in an Aug. 25 letter urging the mayors of Los Angeles and Long Beach to oppose a potential Indirect Source Rule (ISR) proposed by the South Coast Air Quality Management District (SCAQMD). If approved, the ISR threatens to limit the import and export of goods through the ports of Los Angeles and Long Beach.

Specifically, the SCAQMD initial staff proposal establishes volume caps on port activities at Los Angeles and Long Beach.

The trade organizations said the proposed rule would be "counter-productive to additional zero-emission reduction efforts and will actually increase GHG emissions by forcing the diversion of cargo to other North American trade gateways" and "inhibit the ability of the supply chain to finance the equipment and infrastructure upgrades necessary to transition to zero emission infrastructure, defeating the purpose of California's zero emission strategies and the ports' Clean Air Action Plan."
