Government Shutdown 2023: On Thursday September 21, House of Representatives closed sessions without a Continuing Resolution. A week later, the House Republicans are still fractured yet resisting short-gap bipartisan funding resolution from the Senate. General consensus is government headed to shutdown funding gap by September 30th fiscal year end. All government agencies will be forced to contingency plans with "essential staff" on backpay and "non-essential worker" being furloughed without pay. During monthly Trade Facilitation Committer meeting, SF Customs Border Protection was asked if recent cross-border migration crisis would mean local port CBP officers might be assigned to re-enforce the border. San Francisco CBP assured they were not tasked for border staffing and that they are prepared for the possible shutdown. The last government shutdown in 2019 lasted 35 days.

PMA/ILWU Contract After tentative agreement June 13 2023, PMA/ILWU contract was (finally) ratified by all local unions August 30, 2023. For consideration, contract is retroactive to July 1, 2022 for union members to receive retroactive pay increases for several pay periods in the Fall. The new 6 year PMA/ILWU contract is set to June 30, 2028.

Port News: At September 19th Port Efficiency Task Force (PETF) meeting, Ron Brown gave some stats on West Coast ports loss to Gulf and East Coast ports. Citing Bill Mongelluzzo's recent article, Ron had some positives for volumes forecast starting in October.

Support Needed for Land Port of Entry Modernization Trust Fund Act

President Lee shares the below message issued by NCBFAA:

Please reach out to your Congressmen/women for their support in the passing of HR 3135, the Land Port of Entry (LPOE) Modernization Trust Fund Act. For your convenience, the attached generic letter is posted in the Legislative page on the NCBFAA's website, https://www.ncbfaa.org/news-advocacy/write-my-representative.

This legislation will establish a trust fund that will be used to support the essential needs for the land ports:

- (1) construct new ports of entry
- (2) expand and improve existing ports of entry
- (3) procure technology for inspecting and processing traffic passing through ports of entry
- (4) hire U.S. Customs and Border Protection staff.

While waterway-based ports of entry have long had the benefit of a consistent source of federal resources via the authorization of a similar trust fund, our overburdened land-based ports of entry have struggled. The LPOE Modernization Trust Fund Act is needed to properly redistribute much needed resources to LPOE facilities and to ensure the United States' long-term economic prosperity through international trade.

The LPOE Trust Fund will expand, improve, and construct new U.S. ports of entry and support infrastructure to accommodate high volumes of commercial, vehicle, and pedestrian traffic. It will also help critical transit and trade facilities more efficiently complete the inspection and processing of commercial, vehicle, and pedestrian traffic.

JOC Reportage Details Costs to Shippers from EU Carbon Neutral Goals

According to a September 22, 2023, article published by the <u>Journal of Commerce</u>, Maersk and Hapag Lloyd are advising the estimated and significant surcharges shippers will face next year as liners fall into compliance with the <u>European Union's emissions trading system</u>.

Starting Jan. 1, ship operators must pay European Union Allowances (EUA) for every ton of CO2 they emit covering all voyages within the European Economic Area *and* 50% of voyages ending or beginning in European ports. Both carriers advise that the additional costs will be applied as a separate surcharge to all applicable shipments.

Per the article in the JOC, "Maersk has estimated that on Asia-North Europe it will need to charge shippers €70 per FEU, while Hapag-Lloyd expects to charge €12 per TEU. North Europe to the US will generate an expected charge of €81 per FEU on a Maersk ship, while Hapag-Lloyd forecasts a charge of €9 per TEU for North Europe to the US East Coast." These charges will increase over time, rising from 40% in 2024 (cost: \$3.2 billion), to 70% in 2025 and 100% in 2026 (\$9.1 billion). These cost are estimates, because EUAs traded in the ETS could be volatile because of supply and demand factors.


Revenue generated by the ETS will be channeled into the maritime sector to support its transition to <u>alternative energy</u> sources.

(Editor's note: The article cited above was written by Greg Knowler, Senior Editor, Europe, for the Journal of Commerce. Mr. Knowler also reported in an earlier article that alternative fuels being developed by the container shipping industry could be up to five times more expensive than current fossil fuels and these costs will need to be recovered from cargo owners. Looming Government Shutdown to Affect Trade Activity

As members of Congress continue to negotiate government spending levels allotted for the next fiscal year, the United States is poised for its fourth partial government shutdown in the last decade—putting at risk the regular operations of U.S. agencies responsible for trade activities.

A shutdown appears more likely by the day, unless the Republican-controlled House of Representatives and the Democratic-led Senate reach an agreement on spending bills for fiscal year 2024 by September 30, 2023. If negotiations drag on, approximately 438 government agencies will suspend their normal operations starting on October 1, 2023, which will force non-essential federal workers into furlough and disrupt various services critical to U.S. trade activities. Agencies and federal workers deemed "essential" will continue to provide vital services, such as those relating to national security or activities necessary to protect life and property, as well as activities funded outside of the appropriations process.
