Many of you know that CBFANC members went on mission to Washington DC in Feb 2020, and our members visited The Federal Maritime Commission, covered in our March 2020 newsletter

https://www.cbfanc.org/docs/March 2020 Newsletter.pdf discussed how the FMC came out with guidance for carriers and terminal operators regarding demurrage and detention while the containers were at port.

Basic rule was that if there was no opportunity for the importer to pull the container out to mitigate charges, then the importer should not be charged for what is a basically a congestion charge at the terminal. HR 2261 Will Help Protect Brokers From Financial Perils of the COVID19 Crisis

Below is the text of an email sent to the offices of Senators Dianne Feinstein and Kamala Harris regarding HR 2261:

I hope this email finds you well! As you know, customs brokers play an important role in the duty payment process at U.S. ports, serving as a pass-through entity for the collection and payment of duties to U.S. Customs and Border Protection (CBP).

Customs brokers collect duties from importers and pay CBP on the importer's behalf. The customs duties can be extremely high, and many importers have multiple shipments in a short period of time. The duties can amount to millions of dollars. In performing this role, customs brokers are often stuck with an unfair burden when an importer they work with declares bankruptcy. When an importer declares bankruptcy there is a 90-day claw back period and we, as the customs broker, have to pay back any duties paid to us in those 90 days. However, CBP has already received those duties from the customs broker. We are left in the middle holding the bag. H.R. 2261, the Customs Business Fairness Act, requests a technical change in the bankruptcy laws to provide relief for customs brokers who have paid duties to CBP on behalf of importers who subsequently file for bankruptcy. Please find attached an overview of the bill and bill text.



# **Update on Oakland A's Ballpark Fiasco**

Play ball or protect the Port of Oakland? A recent <u>letter</u> was sent to the Port of Oakland which states, "We emphatically agree with the Port Commission that

no project should be approved - whether a ballpark at Howard Terminal or any other ancillary development - without complete assurance that all potential impacts to the Port's primary and core business at the seaport are fundamentally avoided. Everyone, including the Oakland A's, acknowledges that the potential development of Howard Terminal as a housing-office-stadium project is facially incompatible with the heavy industrial maritime operations at the Port of Oakland and its continued success and growth."

**Update on East Oakland Stadium Alliance:** Efforts continue on opposing Oakland As dream of MLB ballpark at Howard Terminal. News outlets shined on As dark side in trying to delay/forgo on monthly lease on Coliseum, also on closed door meeting with Oakland City Council. Meeting with Bay Conservation Development Commission gained understanding of land trust process, as learning BCDC has an Environmental Justice Mandate. Bonus support from Sierra Club also citing environmental justice concerns.

### Dear Port of Oakland: Who's On First?

In a coronavirus-shortened season, the Oakland A's baseball season is about to start in a stadium filled with cardboard cutouts of fans. Ironically, the cardboard cutouts will probably break the A's attendance records of the past couple of decades.

According to the Port of Oakland in 2019, the Portand its partners provide 84,144 jobs in the Bay Areaand contributed \$698 million to state and local taxes. Business revenue, consumer spending and value of goods and services create the Port's overall economic value of \$130 billion.

Yet there is still uncertainty about whether the Port's commitment is to the trade community or the dream of luring the A's and their cardboard cutouts to the waterfront. Way back in November 2019, long before the Coronavirus pandemic, the Port of Oakland hosted a meeting crowded with maritime stakeholders to discuss the proposed ballpark/hotel/housing/office development project at the port's Howard Terminal site. Also in attendance at this meeting were senior port staff and several port commissioners.

The purpose of the November meeting was to discuss "seaport compatibility measures" – mechanisms and safeguards to ensure that the A's proposed development wouldn't impact existing or future maritime operations, waterfront jobs, or the port's own future seaport revenue streams.

REMINDER: PierPass Announced TMF Increase to be Effective August 1, 2020



<u>Beginning August 1</u>, the TMF will be \$33.47 per TEU (twenty-foot equivalent unit) or \$66.94 for all other sizes of container. The TMF is charged on non-exempt containers. Containers exempt from the TMF include empty containers; import cargo or export cargo that transits the Alameda Corridor in a container and is subject to a fee imposed by the Alameda Corridor Transportation Authority; and transshipment cargo. Empty chassis and bobtail trucks are also exempt.

### Will COVID19 Kill the Clean-Ship Movement?



Per the <u>Wall Street Journal</u> (July 1, 2020) the financial impact of the COVID19 pandemic is basically eliminating efforts to cut shipping industry emissions.

In International Maritime Organization (IMO) agreed to improve fuel efficiency by 30% by 2025 and further cut emissions by half by 2050 from 2008 levels. However, the priority for many shipowners will be staying in business, which means leaving climate-change considerations on the back burner.

The European Community Shipowners' Associations says an industry survey found that 75% of its members would either halt or reduce investments in cleaner ships. 30% said they would reduce investments, and 44% advised that putting money into decarbonization would no longer be possible. Shipowners say these efforts will cost around \$50 billion over the next four years.

Further compounding the situation is that mass producing new fuels will be a big challenge as proposed solutions like ammonia are carbon-intensive to produce, and thus fail to reduce emissions over-all. Similarly, the use of batteries would substantially cut cargo space, so even existing trade volumes would require put more ships into the water. Known proposals and innovations are unable to yield the environmental benefits that are sought by the IMO.

# **Consumer Electronics Show CES to be All Virtual** in 2021



Customs brokers and forwarders and logistics professionals have long considered CES held annually in Las Vegas to be one of the most important trade shows of the year. In 2021, however, the event will be strictly virtual due to COVID19 concerns. This development will have a big, negative impact on the struggling hospitality industry in Las Vegas. The CES is the largest event by exhibition space in the country, spanning nearly 3 million net square feet. More than 170,000 people from 164 countries, regions and territories attended the weeklong showcase earlier this year. The virtual CES 2021 will run from Jan 6 to Jan 9.
