Electronic entries/entry summaries, associated with entry types 01, 03, 06, 11, 23, 51 and 52, with APHIS Lacey ACT data, unless paired with other PGA data on the same submission.

Electronic entries/entry summaries, associated with entry types 01, 03, 06, 11, 23, 51 and 52, with NHTSA data, unless paired with other PGA data on the same submission.

Food and Drug Administration (FDA) filings will continue to be allowed in ACS to provide more time for industry to transition to ACE. # View from Washington, D.C. Peter Friedmann

In this supercharged Presidential election year, with no less than 6 current and former Senators at one point running for President, the Hill seems able to conduct business with perhaps less, and certainly not more partisanship than we've been accustomed to during the last seven years. Legislative work on the basic functions of government is getting done no landmark legislation, nothing groundbreaking: rather, infrastructure funding for roads and transit; reform and technological updating of the aviation system; passage of comprehensive updates for Customs policy and organization; even some subtle progress towards a comprehensive Transpacific Partnership trade treaty.

The reality of the limitations of the final year of a two-term President, and the likelihood of a change in Senate Majority from Republican to Democratic, has sort of frozen Congress in place, when it comes to those 'hot button' election-year issues such as gun control, abortion, carbon emission legislation (AKA, the "War on Coal"), and Supreme Court confirmations.

The President has long been aware that with a Republican-majority Congress, he could not get his legislative priorities passed. But the reverse has also been true: without a sufficiently large majority, the Republicans lacked the votes to override a Presidential veto, so Congress has known it could not advance its own agenda. Stalemate. The President has sought to use his Executive Authority to accomplish via regulation, what he could not get Congress to approve. He has had some success, thanks to favorable Supreme Court rulings, and recently he has reenergized the debate on use of Executive Authority by publicly speculating about trying this approach to gain gun-ownership controls. At the same time however, the Supreme Court has issued a tentative ruling suggesting that it may find the President exceeded his Constitutional authority to limit carbon emissions (from fossil fuels) by regulations issued by the EPA, rather than legislation passed by Congress. Again, stalemate.

Because the Supreme Court can play such a critical role in determining the balance of power between Congress and the Executive, the loss of Justice Scalia, the intellectual anchor of the conservative side of the Court, will have great impact. Who replaces him? The normal process is for the President to nominate a new Justice, and the Senate to scrutinize that nominee and vote whether or not to confirm. Will that happen this year? The President knows whomever he nominates (presuming it would be a person holding views similar to his own) will have no chance of being accepted by the current Republican Senate. So, why bother? Perhaps to make a point. But will such a nominee help or hurt Hillary and Bernie? A nominee as 'liberal' as President Obama is likely to propose might be well received by Democratic primary voters, but will emphasize to the independent, middle of the road voters in November, whom Bernie or Hilary will need in order to win, that the Democratic candidate is perhaps too liberal for their tastes. In any case, it would create a major point of contention in the Presidential debates. So Hillary and Bernie might not be eager for the President to make that nomination.

In this year of the unpredictable, with Trump and Bernie more than holding their own far longer than the "experts" predicted, those of us here inside the Beltway, who are more concerned about getting Congress to do the kind of unexciting, non-partisan work that the country needs, will take this brief respite from the election year 'excitement' swirling in all those primary states.



# Industry News & Port Happenings...

## Truck and Bus Tires from China are Subject of New AD/CV Petition

A petition filed Feb. 1 alleges that truck and bus tires from China are being sold at less than fair value and benefitting from countervailable subsidies.

The products covered by this petition are new pneumatic tires, of rubber, with a truck or bus size designation. Covered tires may be tube-type, tubeless, radial or non-radial and may be intended for sale to original equipment manufacturers, fleet owners and operators, or the replacement market.

Subject tires have the symbol "DOT" on the sidewall at the time of importation certifying that they conform to applicable motor vehicle safety standards. They may also have on the sidewall one of the following suffixes in their tire size designation.

- TR – tires for service on trucks or buses to differentiate them from similarly sized passenger car and light truck tires - MH – tires for mobile homes

- HC - a 17.5 rim diameter code for use on low platform trailers

All tires with one of these suffixes in their size designations are covered by this petition regardless of their intended use. In addition, all tires that lack one of these suffixes are included, regardless of their intended use, as long as they are of a size that is among the numerical size designations listed in the "Truck-Bus" section of the Tire and Rim Association Year Book, as updated annually, unless the tire falls within one of the specific exclusions set out below.

Truck and bus tires, whether or not mounted on wheels or rims, are included in the scope. However, if a subject tire is imported mounted on a wheel or rim, only the tire is covered. Subject tires include truck and bus tires produced in China whether mounted on wheels or rims in China or a third country. Truck and bus tires are covered whether or not they are accompanied by other parts; e.g., a wheel, rim, axle parts, bolts, nuts, etc. Tires that enter attached to a vehicle are not covered.

The tires covered by the petition are currently classified under HTSUS subheadings 4011.20.1015 and 4011.20.5020 and may also enter under subheadings 4011.99.4510, 4011.94.4550, 4011.99.8510, 4011.99.8550, 8708.70.4530, 8708.70.6030 and 8708.70.6060.

Specifically excluded from the petition are (1) pneumatic tires, of rubber, that are not new, including recycled and retreated tires, and (2) non-pneumatic tires, such as solid rubber tires.

The Department of Commerce and the International Trade Commission will next determine whether to launch AD and/or CV duty and injury investigations, respectively, on this product. There are strict statutory deadlines associated with these proceedings, so affected companies that wish to protect their interests should contact trade counsel as soon as possible.

#### Subject: Notice to Trade - Recent Changes to the Exemption on Organic Assessments

Industry Stakeholders:

On February 5, 2016, the Agricultural Marketing Service (AMS) will make a recorded presentation available on its website to review modifications to the organic assessment exemption regulations under 23 Federal marketing orders and 22 research and promotion programs, collectively referred to as "commodity promotion programs." The presentation provides an opportunity for you to understand how the amendments to the exemption will be applied to businesses under each of the commodity promotion programs moving forward. The recording can be accessed at <a href="http://www.ams.usda.gov/report-presentation/organic-exemption">http://www.ams.usda.gov/report-presentation/organic-exemption</a>.

Changes to previous regulations expand the exemption to cover all "organic" and "100 percent organic" products certified under the National Organic Program regardless of whether the person requesting the exemption also produces, handles, markets, processes, manufactures, feeds, or imports conventional or nonorganic products. The revisions were authorized by the 2014 Farm Bill. AMS published a proposed rule with request for public comment in the December 14, 2014, *Federal Register* and issued the final rule on December 31, 2015. The expanded exemption takes effect on February 29, 2016.

AMS may conduct additional stakeholder information sessions as needed about the exemption. Contact information for specific AMS programs is available at the end of the presentation. Industry members wanting additional information can contact the board or committee that administers their industry's commodity promotion program. Industry boards and committees may direct questions to AMS personnel who oversee the respective program's activities.
