Filers will be required to file in ACE and no longer permitted to file in ACS the following transactions:

Electronic **entry summaries**, associated with the following entry types, with no PGA data:

- 01 Consumption
- 03 Consumption Antidumping/Countervailing Duty
- 11 Informal
- 23 Temporary Importation Bond (TIB)
- 51 Defense Contract Administration Service Region (DCASR)
- 52 Government Dutiable

Electronic entries and corresponding entry summaries, associated with the entry types listed above, with data for the following agencies:
Animal and Plant Health Inspection Service (APHIS) for Lacey Act, unless paired with other PGA data.
National Highway Traffic Safety Administration (NHTSA), unless paired with other PGA data.

The implementation of these capabilities through ACE means that the filing of the following transactions **will no longer be accepted** in ACS: Electronic entry summaries (Entry types 01, 03, 11, 23, 51 and 52) with no PGA data.

11, 23, 51 and 52) with APHIS Lacey Act data, unless paired with other

PGA data on the same transaction.

Electronic entries and corresponding entry summaries (Entry types 01, 03,

In Port News - An Editorial

What's going on at Oakland Port? A lot and not enough. Recent weeks of closed areas by mid-morning and long lines at SSA are realizing fears of the "new normal". And these reports before Ports America closing regular vessel operations March 31<sup>st</sup> and last gate operations April 27<sup>th</sup>. The dramatic shift of cargo, equipment and traffic to SSA must be daunting undertaking and there must be full appreciation to SSA for their stayed commitment to the Port. That said, what measures needed solve congestion and reduced ports of call? With much at stake, port stakeholders need to work closer and smarter to forge a "better new normal" for our Oakland port.

Are the extended gates working? Extended Saturday gates for One Stops are not fulfilling goal of 950 gate moves. The March 12<sup>th</sup> Saturday gate only had 658 moves. Weeknight gates (Monday-Thursday) for reefer imports and exports show low turnout even with inclusion for One Stops.

What are options for realizing "extra" services for Imports and Exports?

- If less than the 20 containers defined for SSA's One Stops, check with ocean and motor carriers for possibility to draw up own list of 20 containers. This requires pre-arrival planning for clearance and freight release but worthwhile for One Stop option.

- Check <u>http://b58.tideworks.com/forecast</u> as well sign up to eModal which offers daily updates on vessel receiving and terminal updates.
- Sign up for Port of Oakland's daily Seaport Operation email updates for traffic and terminal updates. Send
  request to join at <u>info@cbfanc.org</u>
- Work closely with ocean and motor carriers and for pre-arrival planning. And support truck partners for off-dock equipment needs/returns. Spread the word on a new app on street-turns now being beta-tested. <u>hello@jupigo.co</u>

Lastly, get informed and get involved. With all the current challenges at port, more communications and connections are needed. Join the monthly Truckers Work Group meetings. Held on the 3<sup>rd</sup> or 4<sup>th</sup> Mondays of each month at the Port's Harbor Maintenance Facilities Building at 651 Maritime, Oakland. Co-chairing the meetings are Ralph Reynoso with Port of Oakland Wharfinger Dept.and Henry Osaki with Mutual Express.
